

## Hurn Neighbourhood Plan Residents Survey - February 2020

Welcome to our first household survey that will help us produce a Neighbourhood Plan for Hurn, reflecting the community's needs and aspirations. We are asking every household in the Parish some questions about their housing and employment needs, their thoughts on what is important and what needs to be addressed in our Neighbourhood Plan, which will guide planning decisions in the future.

We know from the Parish Plan consultation in 2010 that most local residents want to preserve the green belt and wooded environment of the Parish. There is also little potential for much building in our Parish, due to green belt restrictions, internationally important heaths, areas which flood and areas safeguarded to support the airport. However if there is a need for development, we can see if there are any suitable sites (which would be the next stage on in preparing our Plan).

Please answer **one survey per household** - if there is more than one person in your household, please try to find a consensus where your answers may have differed, as Neighbourhood Planning is about finding consensus, as a community.

**Traffic and transport:**

It is difficult to predict how traffic levels might change. The airport's new passenger arrivals and departure terminals (built in 2011) can accommodate up to 3 million passengers every year, although it is currently operating well below this number. There is also potential for approximately 50ha of employment development at the airport business parks. The recent improvements to the A338 and B3073 are intended to give the highways network the ability to cope with this level of growth. So, whilst there are limited actions a Neighbourhood Plan can do to address traffic and transport concerns, we can still suggest potential improvements to be considered.
