HURN PARISH NEIGHBOURHOOD PLAN

The Draft Hurn neighbourhood Plan was published in July for an 8 week consultation which ended on 1st September 2023. An independent Planning Inspectorate Examiner, Christopher Collison BA (Hons) MBA MRTPI MIED IHBC, has been appointed to examine the Hurn Neighbourhood Plan. All comments from the consultation have been sent to him for consideration.

He will have visited Hurn and looked around during the consultation period, to familiarise himself with the Parish. In due course the Examiner will provide a review of the Plan and make recommendations in accordance with the 2011 Localism Act and related regulations.
